

Corn maze and parking rules

Admission

Park Sennesräich strongly recommends purchasing tickets in advance at the online ticket shop.
In case of available space, tickets can be bought on-site at the admission check.

Visitors may only enter the corn maze with valid admission tickets through the marked entrance.

Admission tickets have to be kept with visitors throughout their stay in the corn maze
and have to be produced for our staff if requested to do so.
The admission ticket allow visitors to enter the corn maze during the opening times stated.

Entrance authorisation becomes invalid when visitors leave the corn maze.
If visitors leave the corn maze for a short period of time they should contact a member of staff
at the entrance control who will authorise them to re-enter the corn maze.

Minors must be accompanied by an adult.
Accompanying persons and parents are responsible for the children in their group.

Dogs are not permitted at the corn maze.
However they are welcome at the entrance area of the corn maze
but must be kept on a short leash and supervised at all times.
Companion dogs which are marked as such are allowed in the corn maze.
You are responsible for cleaning up after your dog.
A suitable means of cleaning up must be carried at all times (e.g. a poop scoop and disposable bag).

Parking

Visitors to the corn maze must park their vehicles in the designated clients parking area
in front of the building of the hands-on museum.

If a vehicle is parked in a non-designated area, and is therefore blocking traffic or other visitors,
Park Sennesräich will have to tow the vehicle at the visitor's cost and risk.

Pets are not allowed to be left in the car.

General safety

The orders of Park Sennesräch staff have to be followed in the interest of the visitors.

All visitors are asked to behave correctly and appropriately.

Disturbance of the public order, inappropriate behaviour, disturbance of other visitors or of the corn maze operation, verbal or physical abuse, defamation, defiance of the corn maze rules, etc. may prompt Park Sennesräch to take appropriate action, such as a ban from the corn maze, criminal prosecution or similar measures.

Park Sennesräch reserves the right to eject visitors without compensation whose behaviour suggests that they endanger or disturb themselves or other visitors.

Smoking is not permitted in the whole corn maze area.

Visitors must not leave the paths and squares, and not attempt to climb over barriers, fences, and walls.

Using the interactive exhibits

The interactive exhibits at the corn maze are at visitors' disposal for as long as they observe the rules of their use.

Outages of interactive exhibits due to technical or organisational outages or other circumstances shall not result in an entitlement to a full or partial refund of the admission fee paid.

In case of severe weather, Park Sennesräch shall be entitled to shut down the operation of individual or all interactive exhibits for the protection of visitors. There shall be no entitlement to a full or partial refund of the admission fee paid.

Expulsion

The violation of any of the above corn maze rules and regulations may result in ejection from the corn maze without compensation, at the discretion of Park Sennesräch staff and/or management.
